Course Description: This 3 day Human Trafficking class will discuss the laws and legislation that have been implemented and how they affect law enforcement. This class will give patrol officers, investigators, and supervisors additional tools to recognize Human Trafficking indicators occurring within their communities and options when taking enforcement action. This class will also teach the different types of Human Trafficking and new trends that are developing. This class will also have survivors debrief their experience with questions and answers to help with expertise. This course has been updated with new debriefs from recent survivors and investigations. Upon completion of the training, an officer /investigator will be able to utilize a variety of tools for a successful investigation, takedown, and prosecution of the organization or criminal enterprise.
